Title: SUR implementation monitoring, assessments and support

Technical subject matter: In the context of the EUROCONTROL Surveillance Domain, the Surveillance System and Sensors activity supports the implementation, modernisation and optimisation of European ATM Surveillance, enabling Network performance improvements and global interoperability. This aims at the transition to a cost, spectrum and environmentally efficient Surveillance infrastructure meeting the performance needs of the European ATM Network. This activity supports the provisions of the relevant Regulation (EU) No 1207/2011 (Surveillance Performance and Interoperability Implementing Rule, "SPI IR") and its amendments, as well as Regulation (EU) No 1206/2011 (Aircraft Identification Implementing Rule, "ACID IR").
