<u>Technical subject</u> matter:

The Network Manager is engaged in a unique forward looking transformation project. This includes not only the development of state-of-the-art technical systems and the construction of a new operations centre but also a rejuvenation of staff, and a collective uplifting of talent and leadership capability throughout the organisation. The transformation project is a huge opportunity to shape a connected and engaged workforce creating the right culture to drive business success. A more people-centric culture maximising engagement and human connection is a prime objective of the NM people strategy. A set of development initiatives have already been undertaken to translate that strategy into required leadership qualities and capabilities, as described below.

The Executive Management Team (9 leaders) and their direct reports (30+ managers) have completed individual development journeys incl. coaching and they are building team cohesiveness under the leadership of the Director NM since 2019.
